Payment Policy: Payment is due in full prior to transfer of remains and before services are rendered. We accept Electronic Transfer of Funds (ETF), American Express, Discover, Master Card, and Visa.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF AND OVERHEAD\$725.00

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. **(This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) Please note: Immediate burial is not a service we provide.**

EMBALMING N/A

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

DIRECT CREMATION \$995.00

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; minimum cardboard cremation container; protective pouch where applicable, transportation of remains; transportation to crematory; necessary authorizations and cremation, and a temporary cardboard urn.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The Containers we provide are Fiberboard.
