These prices are effective as of **June 1, 2026** but are subject to change without notice. The goods and services shown in this brochure are those we can provide to our clientele. You may choose only those items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for within this contract, we will explain in writing, on the statement we provide, describing the cremation/ funeral goods and services you selected at time of need. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials with or without an outside covering (the containers we provide are fiberboard containers.)

PAYMENT POLICY

To continue to offer our low cost cremation services, we require payment in full at the time of arrangements.

SIMPLE CREMATION (STARTING AT)

\$1,095.00

Our charge for a simple cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs, minimum corrugated box, transfer of remains to funeral home, filing of necessary authorizations and permits. Additional charges for residential, after hours and holiday removals.

IMMEDIATE BURIAL (STARTING AT)

\$1,795.00

This option includes: basic professional services of the funeral director and staff, death certificate and permit processing, overhead costs, local transport of the deceased local transfer of remains to the funeral home, (one attendant included), and utility vehicle for transfer to local cemetery. Additional charges for residential, after hours and holiday removals. Merchandise, cash advances and additional services are not included in our charges for direct cremations, immediate burials, burial at sea, and forwarding or receiving remains.

FULL BODY BURIAL AT SEA (STARTING AT)

\$7,995.00 - *unattended*

This service includes basic services of the funeral director/staff and overhead fees; removal from the place of death; refrigeration; all transportation within Southern California; filing of necessary authorizations and permits; biodegradable shroud; port fees; and full-body burial at sea certificate. Not included: Vessel for hire. Note: The number of people can influence vessel cost. Contact one of our staff to discuss the process, overall costs, and cancellation policy terms and conditions.

FETAL PACKAGE (STARTING AT)

\$500.00

This is a cremation service designed for infants lost before or shortly after birth. It provides a gentle and respectful farewell, offering families a dignified way to honor their child through cremation and memorial options chosen according to their wishes.

PROFESSIONAL SERVICES

1. Basic Services of Funeral Director/staff and

Overhead

\$950.50

This fee includes: conducting arrangements conference, planning services, consulting with family and clergy, shelter of remains, preparation and filing of necessary authorizations and permits, recording vital statistics, coordination with the crematory, cemetery, or other third parties. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, equipment and inventory cost.

This fee for our Basic Services and overhead will be added to the total of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, burial at sea, and forwarding or receiving remains).

2. Cremation (the process)

3. Transportation

\$425.50

This includes removal of the deceased from Hospital/Nursing Facility within 30 mile radius, (additional mileage is \$3/mile). (Additional charges for residential, after hours and holiday removals.)

4. Forwarding of Remains

\$2,695.00

This includes basic services of funeral director and staff, overhead costs, preparation of remains (including embalming), and utility vehicle to local airport 30 mile radius, (additional mileage is \$3/mile.). (Additional charges for residential, after hours and holiday removals.)

5. Receiving of Remains

\$2,045.00

This includes basic services of funeral director and staff, overhead costs, shelter of remains, and utility vehicle to local cemetery (30 mile radius; additional mileage is \$3/mile) or transport to our crematory. (Additional charges for after hours and holiday removals may apply).

Embalming

\$950.00

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as simple cremation or immediate burial.
